	- 2) Time commitment from voluntary sector. Often small services with people	

on limited time availability. We're directly commissioned, sometimes there's challenges about how as a commissioned service we feel we can use our time that's being paid for by our funders to commit to a discussion that may not be immediately relevant to the service we're delivering.

- Need to think about how to best engage the voluntary sector.
- Tend to be quite meeting heavy. If something we want to explore and unpick we tend to have a meeting. We could probably do chunks of that work better by using some of the IT that's available through quick surveys. Gather opinions and feedback. Get information that we would probably have been chatting about that for a long time in a meeting. We can be more savvy.
- Regarding the jargon and how it feels; that doesn't surprise me and I sometimes feel a little like that as well. One of the things we need to look at is the leadership of some of the projects. This is a bit of a challenge. We have a conversation about the time people have available, I wonder with your time and support as a sector the voluntary sector could be a bit more of a driving force. The projects can be chaired or driven by anybody. I wonder whether if you look at the projects at the moment and count how many are chaired by council officers, it's a very high council driven thing. It's not because council wants to drive it, it's because nobody else has stepped forward. The council steps in when nobody steps forward. I wonder whether we can have conversations, not necessarily about running the whole project, but task and finish groups and things linked to some of these pieces of work are we in a position where the voluntary sector could take a more, if not the front seat, more prominent seat and co-chair some of these things. Always a balance between profile and influence, but we've got less time in this sector than arguably council officers and CCG officers have got.
- On topic of leadership and leadership within the partnership and leadership within the community and voluntary sector – as community engagement manager – the collective working, that collaborative working is crucial when it comes to community engagement and when it comes to the work we do and area board level funding of community projects to impact upon children and young families issues. Sometimes there's a dearth of leadership, sometimes when we all come together to talk about the effectiveness of these projects, especially in the context of FACT, there seems to be an absence of leadership. To give an example of leadership working in a particular programme of work, we have a collaboration of arts organisations running a project called celebrating age. Put together about 3 years ago and given £300k by the Arts Council and was so successful that over the next 5 years it's got half a million pounds from the lottery. It's been heavily evaluated and monitored throughout. A key strength is it has a lead partner steering it throughout, and the lead partner has remained consistently the lead partner since day one. Also has a programme manager; someone paid to deliver it. Arguably is accountable for how it's going. Need to be collaborative. Need to collectively deliver these things together. Clarity as to who the lead partner is, is what I seek.

- voluntary sector attended that and were a big part of that. One thing to be mindful of is when projects get rijigged or the FACT projects are reassessed, you keep that momentum going and making sure the people previously involved in the projects don't drop off the invite list. A proper handover.
- Think it's really important that voluntary sector is involved in these groups. Especially the earlier supporting communities and the voluntary sector helping some of those children, young people and their families. Voluntary sector organisations often quite small. Wider perception that we're this massive organisation and we've got 4 part time workers doing the work. Our caseloads are tripling, and I'm sure other organisations are as well. Need that input that the voluntary sector don't feel like things are just being put down on them. Need to have a really open conversation about workloads.
- Near the beginning of FACT a family friendly newsletter was put out about FACT. Think it would be good for families to have the same thing done again. Wasn't done in a technical speak, but in a very family friendly kind of way.
- Echoing very much what Karen and Trudy have said, from the perspective of area board funding, we fund hundreds of groups that provide support through the voluntary sector to children and families. That's the difficulty, there's lots of small groups doing their thing. Under the umbrella of FACT, they all do fit under it but the reality is each organisation is responding to its ambitions, its articles of association and its priorities as a voluntary sector organisation. That's why they exist. Sometimes voluntary sector seen as this homogeneous thing that should be responding and part of a partnership. It should, it's vital and important. Equally partnerships need to recognise that they're delivering what the FACT ambitions are but each individual voluntary sector organisation doesn't see itself as delivering FACT, but delivering what it set out to deliver. There's middle ground there that needs to be recognised. Very keen to be involved, particular the Earliest Support in Communities. Even if its mapping some of the voluntary sector groups we know are doing stuff and providing funding to.
- Does that FACT board know what all the voluntary orgs are doing? Need to work harder and voluntary sector is key in it.
- This is part of the clarity bit, the T in FACT, the Transformation bit I think historically FACT has been everything to do with Children and Families, work in Wiltshire has just been dumped under this umbrella/bucket. It felt when I took on this job nearly 2 years ago that it was more of a bucket where everything was chucked and things got mashed up and you couldn't really see what was in the bucket. The conversations with the boards has been very much recently, in the last 12 months, about focus on the really big important transformation items.
- The job of FACT, I don't think, is to know everything about everything and to tell everybody everything about everything. Its job is to see in amongst these are the big things that if we can work together and do them better, differently, we have an opportunity to really change outcomes for families in Wiltshire. That's what FACT is about. Spotting those things and understanding them and then doing them better. Not trying to be all things to all people.
- Coming out of COVID and looking at the existing projects, the partners view around the table is that the one thing we really need to focus on and work on

- collectively is what does early intervention need to look like in Wiltshire. This is massive.
- Collective view is it's not joined up enough. We don't understand it. You can't see it. If we can't' as agencies and professionals and vol sector groups we're all saying we can't see It what must it be like for families.
- Priority we're exploring going forward at the moment is this big idea we need to join up and communicate and understand what early help currently looks like and what we would like it to look like in the future.
- Things like mapping what we currently have is vital. We don't currently have an overview in an easily understandable map of what all the different groups/organisations/services/voluntary/statutory what are we all doing in Wiltshire to try and support kids and families. All have our websites and newsletters but pulling it together is like knitting fog in Wiltshire. This is what the partnership is recommending we take forward as our big piece of work.
- Trying to do a business case trying to understand and explain why at the moment. If we do go forward with this it's a great example why we need the engagement of the voluntary sector right. It's role and input, relationships etc are so vital to getting it right. If we don't get that bit right, the services the council offers for instance will not be effective unless we understand and work with the voluntary and community groups to get the foundation blocks, the earliest support in communities right. Everything else, when family's needs can't be met in communities; when they are more acute, more complex, we've got to get the base right so the services do what only they can do. Got to enable and equip the voluntary & community sector to do what only it can do.
- Early thoughts, but expects it to be signed off by the exec. Going forward expects this to be FACTs dominant agenda going forward.
- The Alternative provision; how do I know who the membership is currently on the FACT board in that area? That's the area as an organisation that's the sub group we'd be interested in.

	- In Wiltshire how are you funded?	AB
	- Years funding from CCG through NHS. Takes it through to summer next year.	JD
	 At Barnardos and manage early mental health service that we're commissioned to provide in Wiltshire up to age 18. Overlap between us. There's a lot of different interventions around at the moment around early mental health. Keen to ensure we're joining that up. Risk families get confused about who's doing what. Opportunities for us to refer into your service? There's a need for us all to coordinate. 	IJ
	 Within Oxfordshire been running this longer, I manage mental health support teams in schools based offer. We do sometimes step up age wise to the mental wealth academy as they're coming to the end of it but still need a little bit more and other CAHMS teams won't touch them as they're 17 and a half. Happy for referrals to come for other orgs, even if service has same age group but their wait list is longer. Enough need and adding an extra layer. 	JD

- Mentioned around 30% young people you help already have diagnosed mental health condition. What do you define as moderate for your service?	TS
- General guidelines for mild to moderate and for the moderate end, that young person (or adult because it's the same for them) are able to maintain a pretty standard day, but have impact on them in certain situations. Not situations where they can't leave the house, or engage in jobs or training. Able to do that kind of level engagement but find it tougher than others, or find certain sticking points. More specifically don't particularly work with cases that are self harming. That's a sliding scale as you can have mild self harm, and we can probably work with that. Anyone significantly and currently self harming we can't work with. Don't work with young people contemplating suicide and having suicidal ideation as that's more complex than we're able to support. - If you did have a referral were those things were happening. Would you signpost to AWP?	TS
- Signpost to wherever the relevancy is; might be GP to access adult services or CAHMS. We won't just say no, we'll look to signpost.	JD
 In Wiltshire we have Young Peoples Mental Health Network which Judy Edwards set up and Amy McClean chairs. Hopefully you're networked into that as there's about 90-100 orgs that are doing young people mental health support work in one form or another. The community engagement aspect of this. contextual safeguarding, looking at issue of sexual health. In that arena of contextual safeguarding so many of our young people are presenting with real issues when it comes to being the victim of some sort of sexual misconduct. How as professionals in a contextual safeguarding way should we respond?	
 Through community engagement different levels of community that we should be engaging. Whether well trained but voluntary people coming into schools adding capacity and our own voluntary and community sector. Also, then the communities of psychotherapists. How are the psychotherapists responding to mild to moderate low mood and how that's networked into your work. 	
- From therapeutic point of view, we're not therapists. Don't have ability to diagnose and have that therapeutic approach in an official way. About community perspective. About getting to know each individual young person and finding out what's the best engagement method for them which feeds into that safeguarding side of things. Getting to know other organisation out there and see if can link in.	JD
